

## MARS WRIGLEY SUMMER MUSIC WAWA SWEEPSTAKES

### OFFICIAL RULES

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. SWEEPSTAKES DESCRIPTION:** Mars Wrigley Summer Music Wawa Sweepstakes (the “Sweepstakes”) begins on 6/12/23 at 12:00:00 AM Eastern Time (“ET”) and ends on 7/31/23 at 11:59:59 PM (ET) (the “Sweepstakes Period”).
